## PRESIDENT'S MESSAGE

As the Governor proceeds along with his appointments, KRPGA would like to welcome and congratulate the new Commissioner Doug Vincent-Lang. Commissioner Vincent-Lang has a long history with the ADF&G. KRPGA looks forward to developing a professional relationship and working with Mr. Vincent- Lang, along with the leadership of the new Director of Sportfishing, Dave Rutz, and Director of Commercial Fishing Sam Rabung. All the different user groups know how complex the upper Cook Inlet fishery is to manage. KRPGA has been involved in management decisions since the early 1980s. We will continue to work with ADF&G.

During the last 15 years on the Kenai, we have changed our culture as professional guides. We have helped put in place protection tools to put big fish on the spawning beds in order to see 50, 60, and 70 lbs. kings in the future, spawning closures at tributary streams, going from treble hook to single hook, and working with the Department in season to restrict the use of bait when necessary.

Something I would like to see return is the "Release a Hog" program. This was a positive tool even though it was an expensive one. In late May and the first two weeks in June 2017, I personally experienced what I had hoped for: a solid run and some impressive size Kenai kings. However, seeing this kind of return several years over the next 10 would make us all feel better.

We also would like to welcome our new Director of State Parks Ricky Gease. Director Gease has been involved with shaping the fish history of the Kenai Peninsula for as long as I have known him. He brings a tremendous amount of knowledge to this position. Congratulations Director Gease.

Looking to the future of the 2020 Board of Fish meetings, we are ahead of the curve with our proposals. As of February 1st, we have had four meetings and they had some good turnout and good ideas on how to get more fish in the Kenai, Kasilof, and Mat-Su River systems. We will be working with Kenai River Sport Fishing and other river users to come up with some consensus on issues that we want to address regarding in-rivers. Whether you show up to the meetings or not, it is important to communicate with your fellow guides, local anglers and personal use fisherman that all want more fish in the Kenai. The value of sportfish to Alaska and the Kenai Peninsula has grown exponentially over the last 2 decades. It is time that our friends and people in this great state realize how dependent this renewable resource is.

As president of the Association, I continue to feel it is my duty to call on all guides to pursue their clients, friends, and family to join us as sport fisherman. We all have one common goal and that is to provide a responsible opportunity to harvest fish and recreate on the Kenai Peninsula in a sustainable manner.
